By filling out, signing and faxing back this open registration form to the TSC office on or before **June 15, 2010**, you as the coach/advisor have reserved attendance at a TSC Summer Cheer/Dance Camp, as well as locked into the late registration rate. The TSC office fax number is at the top of the page - (310) 862-6743. The space reserved for your program is an approximation and cannot be confirmed until actual numbers are registered with TSC and a deposit is received. **To GUARANTEE a spot at one of our summer camps at the late registration rate, a deposit of \$50 per person will be due in the TSC office no later than one week after your program's tryout dates.** For example, if your tryouts are held on May 7, your deposit is due on May 14. There will not be any refund on these deposits. If a deposit is missed, you automatically forfeit the late registration rate and will be subject to the registration rate set at that time. For programs with tryouts in late May or June, there is no deposit owed as your *full camp payment* is due one week after your tryout date. All final full camp payments are due no later than **Tuesday June 15, 2010**. TSC will work closely with all coaches/advisors/schools to accommodate all special circumstances with advanced notice. For coaches/advisors/schools that pay the deposit prior to their tryout date, to ensure a guaranteed spot at camp, TSC can offer deposit re-imbursement back to that coach/advisor/school upon timely payment in full.
